(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

*Clara M. J. Black, her heirs and assigns*  
All that certain lot or parcel of land situate, lying and being in Greenville Township, County and State aforesaid near the City of Greenville on the Western side of Aberdeen Avenue and being better known and designated as lot No. 13 of Park Hill, a subdivision of Mary B. Lewis property according to a plat made by R. E. Dalton, Engr. July, 1923, and having according to said plat the following metes and bounds, to-wit: -  
Beginning at a stake on the Western side of Aberdeen Avenue, the joint corner of lots Nos. 12 and 13 and running thence with the joint line of said lots N. 62.50th. 180 feet to a stake, the corner of lot No. 35; thence with the line of that lot S. 27.10th. 70 feet to stake, corner of lot No. 14; thence with the line of that lot S. 62.50th. 180 feet to stake on Aberdeen Avenue; thence with the Western side of said Avenue N. 27.10th. 70 feet to the point of beginning.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said

*Clara M. J. Black, her*

heirs and assigns, forever.

Nevertheless upon the following conditions, which conditions are part of the consideration for this deed and are expressly for the benefit of all owners of lots as shown on plat above referred to, to-wit: (1) No building shall be erected nearer to the abutting sidewalk than thirty-five feet nor shall any dwelling be erected upon said lot costing less than four thousand dollars. (2) The property herein conveyed shall never be sold, rented, or otherwise disposed of to a person, or persons, having any percentage of negro blood. (3) The property herein conveyed shall never be used for other than residential purposes and no residence shall ever be erected upon said lot which shall cost less than four thousand dollars.
