J. G. Lynch, his heirs and assigns:
1. All of that tract or parcel of land situate near Chick Springs, in the County and State aforesaid, and described as follows: Beginning at an iron pin in center of old road in direction line thence 4.33.15 N. 31.5 E. feet to an iron pin, thence 2.56.36 E. 23.5 E. feet to an iron pin at Lake View Avenue, thence crossing the head of said Avenue 2.19.22 E. 24.5 E. feet to a stake, thence 2.16.34 E. 22.8 E. feet along said Avenue to a stake, thence 2.0.43 E. 11.2 E. feet to Highway Avenue, thence 2.55.58 E. 104.9 E. feet along said Avenue to an iron pin, thence 4.11.30 E. 3.5 E. feet to stake on National Highway, as it ran December 1915, thence 11.16.45 E. 11.7 E. feet to stake, thence 11.37.51 E. 1.20 E. feet to an iron pin, thence 11.47.16 E. 10.7 E. feet to an iron pin, thence 11.64.03 E. 15.8 E. feet to stake in said Highway, thence 11.19.03 E. 13.5 E. feet to stake in center of said Highway where old road intersects, thence 11.64.54 N. 9.3 E. feet to iron pin in center of said old road, thence along the center of said old road 11.64.54 N. 515.9 E. feet, more or less to the beginning corner containing 3.32 acres more or less according to survey of A.
