KNOW ALL MEN BY THESE PRESENTS, That I, C. J. Larsen, of the City of Charles-

ton,

in the State aforesaid, in consideration of the sum of Ten DOLLARS,

to W. L. Anderson, in hand paid at and before the sealing of these presents by S. O. Patterson, of the City of Greenville, in said State

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said S. O. Patterson and his, heirs and assigns forever all that certain lot, piece or parcel of land situate lying and being in the State of South Carolina, in Greenville County and Township, a short distance north of the corporate limits of the City of Greenville, consisting of the south end of Lots numbered two (2), three (3), four (4) and five (5) in Block "E" of the Buist property, as shown by a plat thereof recorded in the office of the Register of Deeds, Conveyance for Greenville County, in said State, in Book 16, at page ten (10), and including all of said lots except the portions thereof fronting on the south side of Buist Avenue and extending southward therefrom for a depth of one hundred and sixty (160) feet. The lot of land intended to be conveyed hereunder has according to the said plat, the following metes and bounds, to-wit: Beginning at a stake on the east line of Lot number one, as shown on said plat (now belonging to H. J. Poe Jr.), one hundred and sixty (160) feet southward from the south side of Buist Avenue; said stake being on the south-west corner of the lot conveyed by me to John A. Curton and Peter F. Curton by deed recorded in said office in Deed Book 87, at page 393; and running thence along the line of said lot number one S. 9° 45' W. two hundred and ten (210) feet to a stake on the north side of Ashley Avenue; thence along Ashley Avenue N. 87° E. four hundred and eight (408) feet to a stake on the south-west corner of Lot number six (6), as shown on said plat; thence along line of last mentioned lot N. 9° 04' E. one hundred and sixteen (116) feet to a stake which is one hundred and sixty (160) feet southward from the south side of Buist Avenue; thence N. 80° 15' 24" (the intent being that this course shall run parallel with Buist Avenue and one hundred and fifty feet distant therefrom) along line of other land still belonging to me and along the rear line of the lot conveyed by me to Carolina Lumber Co. on or about the day of October, 1923, and along the rear line of the lot conveyed by me to the said John A. Curton and Peter F. Curton by the deed above mentioned, four hundred (400) feet to the beginning corner.

This is a portion of the land conveyed to Ashley A. Butler, W. Carl Wharton and myself by H. B. Buist by deed dated July 26, 1912, and recorded in said office in Book 16, at Page 55. Ashley A. Butler sold his one-third undivided interest in these lands to W. Carl Wharton by deed dated September 17, 1912, and recorded in said office in Book 16, at page 61. W. Carl Wharton sold said undivided one-third interest and his own undivided one-third interest in these lands and conveyed them to the executors of the will of H. B. Buist deceased by deed dated August 2, 1913, and recorded in said office in Book 22, at page 539, and said executors undivided two-thirds interest in said lands by deed dated October 24, 1913, and recorded in said office in Book 21, at page 559. There is no lien or encumbrance on said lot or any part thereof by mortgage, judgment or otherwise.
