All that certain piece, parcel or lot of land situated, lying and being in Greenville Township, Greenville County, State of South Carolina, near the Augusta Road School site, on Argonne Drive, and being shown as lot # 27 of the property of C. B. Martin, as shown on a plat of record in Book "F", page 102, and having, according to said plat, the following meter and bounds, to-wit:
