C. H. Garrison: All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the corporate limits of the City of Greenville on Jones Avenue, and being known and designated as Lot Number Fifteen (15) on plat of property of W. C. McDaniel recorded in Plat Book K, page 186, R.M.C. Office for Greenville County, and having according to said plat the following acres and bounds, to-wit:  
Beginning at a point on Jones Avenue, corner of lots fourteen and fifteen, and running thence along joint line of said lots S. 89 E. 193.7 feet; thence S. 5-08 W. along joint line of lots fifteen and twenty-four 70-18 feet to corner of lot sixteen; thence along joint line of lots fifteen and sixteen N. 89 W. 185.6 feet to point on Jones Avenue; thence along Jones Avenue N. 1 E. 70 feet to the point of beginning.

The property herein conveyed is a portion of the lands devised to me under the last will and testament of my father, J. A. McDaniel, on file in Apartment 171, file 20, Probate Office for Greenville County.  
This conveyance is made subject to the following conditions and restrictions, to-wit:

(b) That said property shall not be conveyed, leased or in any manner disposed of to persons of African descent.
