in the City of Greenville, Beginning at a point on  
the middle side of West Market Street twenty-four feet  
east of the northeast corner of North and Laurens  
Streets, being the corner of Dr. J. T. Cade, and run-  
ning thence with his line in a northerly direc-  
tion of forty-eight feet or more to line of Mrs. Viola  
L. Promastor; thence with her line in an easterly  
direction parallel with North Street forty-eight  
feet to stake; thence southerly with line of R. J.
