Chapman, her heirs and assigns forever: All that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lot No. 3 of the Estate of J.A. Davenport, as shown on plat by R.E. Dalton, C.E., December 1924, and being more particularly described as follows: Beginning at an iron pipe on west side of Cureton Street, joint corner of Lots Nos. 3 and 4 and running thence N. 31-41 W. 185.1 feet to an iron pipe, joint corner of lots 3 and 4 thence N. 63-42 E. 60.3 feet to an iron pipe, joint corner of lots 2 and 3; thence S. 31-41 E. 179.4 feet to an iron pipe on Cureton Street; thence along the western side of Cureton Street S. 53-19 W. 60 feet to the point of beginning, and being the same lot of land conveyed to me, the said D.W.
