the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. G. L. Parfond, all that piece of land in Oaklawn Township in Greenville County, State of South Carolina in the City of Greenville, further described as East Washington Street beginning at an angle on the south side of East Washington Street so far and four inches or towards from the Eastern boundary line of lot No. 19, in part being a right of way running the same along said Washington Street about 18 feet and bounded to the west by a public road running along the northeast corner of lot No. 19, about 11 feet to the left of the right of way, Charlotte Street and Western Carolina's Railway, thence along said highway 110 feet in a straight line to the beginning corner containing Ninety-two, one hundredths (92/100) of an acre, more or less, described by W. H. Rice, the 10th day of March, 1911, bounded by the roads of S. H. Rice & W. H. Rice, and J. G. L. Parfond and J. G. L. Parfond manufacturing Co.

Also all that other tract of land in Oaklawn Township in Greenville County, State of South Carolina, on a creek, waters of Saluda River and described as follows: Beginning at a corner given in the center of the road leading from Elizabethtown to Arden, thence N. 45° 40' E. 10.01 to stone in creek, thence down the creek about 19 $\frac{1}{2}$  rods to corner in the road thence S. 81° W. 12.7 to iron pin in rear road otherwise S. 16° E. 2.57 to road thence practically parallel with road about 100 feet therefore S. 18° 28' 59" to center of road thence S. 42° 15' E. 1.36 to the beginning corner containing 1.247 acres more or less, subject however to the same reservations set out in the deed to me recorded in the R.
