(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

*La Besside Realty Corporation, et al. successors*  
and assigns of  
All that piece, parcel or tract of land situated,  
lying and being in the County and State  
aforesaid, and in Ward of three of the City of  
Greenville, and the South side of Washington  
Street, and described as follows, to wit: Be-  
ginning at a point on the South side of  
St. Washington Street, twenty feet West of the  
Northeast corner of the Washington Street  
lot, and running thence in a southerly  
direction, on a line parallel with the line  
of the said St. Washington Street (Male Company)  
lot ninety-five feet; thence in a westerly  
direction on a line parallel with the South  
side of Washington Street, twenty feet; thence  
in a northerly direction, on a line parallel  
with the first described line, ninety-five  
feet to Washington Street; thence with  
the South side of Washington Street, twenty  
feet to the beginning corner.

As a part of the consideration for

mortgage also covers property on Richardson  
Street (hereinafter described).
