*E. Godfrey Webster: All that certain piece, parcel or lot of land in the City of Greenville, in the County and State aforesaid, fronting on Calvary Street and having the following meter and bounds: beginning at a stake on the west side of Calvary Street at the corner of lot of Josephine Williams; this point being 43 feet northward from the corner of Nichols and Calvary Streets; and running thence northwardly along Calvary Street, sixty five + 67/100 feet to a stake thence N. 61° 35' W. eighty eight + 65/100 feet to a stake; thence S. 28° 15' W. sixty five and 67/100 feet to a point in Josephine Williams line (which point is 88.35 feet more or less westward of Calvary Street); thence along said Williams line S. 61° 25' E. eighty eight + 35/100 feet to the beginning point on Calvary Street.*
