Mackey, the Executrix of said will, and whereas, I am now acting as such Executrix of said will, provides that the Executrix shall have full power to execute deeds and to advance to any one or more of the children of the said James T. Mackey such sum of money or portions of property as I, the said Executrix, might think would be for the best interest of any one or more of said children, And,

whereas, on or about November, 13th, 1923, I as Executrix aforesaid advanced to Arthur H. Mackey, the son of the said James T. Mackey, deceased, and my son a certain lot of land belonging to the Estate of James T. Mackey, my said deceased husband, known as the western part of lot No. 4, as shown on plat recorded in plat book 5, page 20, and as described in my deed recorded in Deed Book 76, page 225, in P. M. C. Office for said Greenville County, And,

Whereas, I failed to state in the said deed made by me individually and as Executrix of the will of the said James T. Mackey, deceased, (recorded in Deed Book 76, page 225) that the conveyance to my son Arthur H. Mackey constituted an advancement to him out of the estate of his Father, under the terms of said will, And,

Whereas, said Arthur H. Mackey, subsequently conveyed said lot to J. R. Copeland for Value, by deed dated June 6th, 1924, recorded in Volume 91, page 510, P. M. C. Office for Greenville County. Now therefore, in order to perpetuate the fact and to show that said leg was regularized, authorized under the will of said James T. Mackey.

Know all men by these presents, I, that I, Nellie H. Mackey, individually and as Executrix of the will of James T. Mackey, deceased, in the County of Greenville, and in the State aforesaid in consideration of the sum of one (\$1.00) dollar to me paid by J. R. Copeland in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said J. R. Copeland, his heirs and assigns, forever, all that piece of land in lot of land in Greenville Township City of Greenville, County of Greenville, State of South Carolina on the East side of Summer Street, being the western part of lot No. 4, plat recorded in said book 5, page

in the W. C. Office for Greenville County, and having the following metes and bounds, to wit,

Begins on Summer Street Southeast corner of lot No. 3, thence with line of lot No. 3, 2, and 1, S. 70-27 E. 140 feet thence S. 5-15 W. 54 feet to Northwest corner of lot No. 5, thence with line of lot No. 5, N. 70-27 W. 140 feet to Summer Street, thence with said street N. 18-15 E. 54 feet to the beginning corner.

Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging within and incident or pertaining.

To have and to hold all and singular the premises before mentioned unto the said J. R. Copeland, his heirs and assigns forever.

And I do hereby bind myself, my successors and my heirs executors and administrators, to warrant and forever defend all and singular the said premises unto the said J. R. Copeland, his heirs and assigns, against myself, my successors and my heirs, lawfully claiming to claim the same or any part thereof.
