In the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Heatwoode W Lucas

all piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

Lieuute on the north side of Prentiss Avenue in the City of Greenville, being the greater part of lot no 3 Block E Cagle Park East Shown by plat recorded in plat book "C" page 938 and being more particular described in the following:

Beginning at a point on said Avenue at the joint corner of lots nos. 2 and 3 and runs thence along said Avenue S. 50-46 E. 60.6 feet; thence S. 34-08 E. 109.8 feet; thence in a straight line in a northeasterly direction to the joint corner of lots nos. 1 and 3 where said corner intersects the rear line of lot no 4; thence S. 31-29 W. 200.6 feet to the beginning corner.

I subject, however, to the following restrictions which are a part of the consideration for this deed and are made for the benefit and protection of the other lots shown on the plat above referred to, which restrictions shall remain effective for a period of twenty years from the date of Deed to C. B. Martin from Cagle Park Company to wit:

(1) This property herein conveyed nor any part thereof shall be sold, rented nor otherwise disposed of to negroes.

(2) The said property shall not be used for any unlawful business nor for anything which would constitute a nuisance.

(3) The property herein conveyed shall not be re-cut nor subdivided so as to face any other direction than as shown on said plat.

(4) No building shall be erected upon said property within 25 feet of the present line of Prentiss Avenue.

(5) No building costing less than Twenty-five hundred (\$2500.00) Dollars shall be erected upon said lot other than out buildings appurtenant to a dwelling.

The above described land is a part of the same conveyed to me by Jessie R. Morgan on the day of June 1926, deed recorded in office of Register of Mesne Conveyance for Greenville County, in Book 62, Page 143, together with all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the said Heatwoode W. Lucas his heirs and assigns forever.

AND do hereby bind myself, my wife, heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said Heatwoode W. Lucas his heirs and assigns, against myself and my wife heirs, and every other person whomsoever lawfully claiming, or to claim, the same, or any part thereof.
