Bryant, and in the event of his death before the life tenant the remainder to go to the Colored Methodist Episcopal Church, which at the time the will was drawn was John Wesley Methodist Episcopal Church, a corporation, and the Mattoon Presbyterian Church, both of Greenville, South Carolina; and

Whereas at a meeting duly called the John Wesley Methodist Church a corporation organized under the laws of South Carolina, has decided to release its contingent interest; Now, Know all men by these presents, that the said John Wesley Methodist Episcopal Church, in consideration of the sum of One Thousand Dollars, to it in hand paid at and before the sealing and delivery of these presents by the grantees hereinabove named, the receipt whereof is hereby acknowledged, has granted, sold, conveyed, released and remised and does hereby grant, sell, convey, release and remise unto Alice Thompson Bryant and Benjamin F. Bryant, their heirs and assigns forever, all and every right, title and interest whether contingent or otherwise, of, in and to all the land owned by the said Ann White at the time of her death wheresoever the same may be situated, and especially that lot upon which she resided, situate in the City of Greenville, State of South Carolina, on the north side of West Washington Street, having a depth of eighty-three feet, more or less, and extending westward from the property of the First Presbyterian Church to Academy Street.

At the time the will was drawn there was in the City of Greenville only one colored Methodist Episcopal Church, which is now known as John Wesley Methodist Episcopal Church.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee hereinabove named, and their heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinabove named, and their heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
