Lee Greene, and his heirs and assigns, ALL of the following described real-estate, to-wit: First:- All that certain place, parcel or lot of land situate, lying and being in the State and County aforesaid, in Greenville Township, in the City of Greenville, on the South side of Goodwin Street, in Ward One of the said City of Greenville, and described as follows, to-wit:- Beginning at a stake on the South side of said Goodwin Street, 51 feet and 5 inches in a westerly direction from the Southwest corner of the intersection of Goodwin Street with Shurts Alley, at corner of lot 5, and running thence with Line of lot 4, in a Southeasterly direction 94 feet and 3 inches to a stake; Line of lot 4 in a Northwesterly direction 94 feet and 5 inches to a stake on Goodwin Street; thence with Goodwin Street 4. 59 1/2 feet and 5 inches to the beginning corner, and being known as Lot #5 as shown by plat recorded in Plat Book A, at page 149. This is the same land conveyed to me by L.T. Batson by deed dated Sept. 5th, 1921 and recorded in the R.I.C. Office for Greenville County in Volume #62, at page 243, to which deed and plat reference is hereby made.
