Hall All that certain piece, parcel and lot of land situate, lying and being on Perry Avenue just beyond the corporate limits of the City of Greenville in the County of Greenville, and State of South Carolina. And being more particularly described as follows:

Johnson, thence south along the line of my lot a distance of ten feet to a stake, thence west a distance of seventy feet to the line between me and C. T. Johnson lot, thence east along and with the line by said H. A. Johnson a distance of seventy feet to the beginning corner, thence ten feet by seventy feet.
