(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said E. W. Brown, his heirs and assigns forever, all that certain piece, parcel or lot of land situated, lying and being in Greenville Township, County and State aforesaid, near the city of Greenville, South Carolina and designated as lot No. 58 in Block "D" of the subdivision known as Aqueta Court, as shown on a plat of record in the C. M. C. Office for Greenville County, South Carolina in the Plat Book "2", page 124, and having according to said plat, the following metes and bounds, to wit: Beginning at an iron pin on the Southern side of Aqueta Court, joint corner of lots Nos. 57 and 58, and running thence with the joint line of said lots S. 39-22 E. 164.8 feet to an iron pin corner of Lot No. 68; thence with line of lot No. 68, S 51-20 W. 59.83 feet to an iron pin in line of lot No. 59; thence with line of Lot No. 59 N. 39-21 W. 169.9 feet to an iron pin on Aqueta Court; thence with Aqueta Court N. 55-30 E. 60 feet to the point of beginning. As a part of the consideration herein expressed the grantee assumes the payment of \$588.11 the balance due on a mortgage executed by the within grantor of Melville C. Weatherall as trustee on May 8th, 1923 to secure the sum of \$530.62, which mortgage covers the within described premises, and is recorded in the C. M. C. Office for Greenville County in Vol. 115, page 19, of the mortgage records.
