(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

*Mrs. L. B. Poy Singer her heirs and assigns, All that lot or parcel of land situate in what is known as East Cuckbrook, near the city of Greenville in the County and State aforesaid, and more particularly described as follows.*

*Beginning at the corner of lot No. 1 on the north east side of Park Road, and thence with the line of that lot to the 112.6 feet truce & 24.15 & 219.5 feet to the corner of the said lot, thence along the line of that lot S. 48.30 W. 118 feet, to Park Road, thence along said road N. 24.25 W. 236.7 feet to the beginning corner, being part of lot No. 5 as shown on plats recorded plat, Book 6, page 159. And is the same, said conveyed to me by Bertha Vaughan, dated June 11th, 1924 recorded in book 91, page 306. The boundaries & distances are in accordance with a recent survey of the said lot by G. M. Furman, and is the actual extent of said lot No. 5. Although the deed to Bertha Vaughan and the plat recorded as aforesaid erroneously name the front and back lines as being approximately 20 feet shorter than is found to be by actual measurement of the land.*

*I grant the purchaser the privilege of the use of the present water pipe conveying water from Spartanburg Road to said premises, so long as the use of said water and pipes does not affect the flow of water to the houses located between these lots and the Spartanburg Road and so long as said pipes are in usable condition, but I am not responsible for the use, repair and maintenance of said pipes, the purchaser of said lots assumes and agrees to pay for all water so conveyed and used on the premises conveyed to her in this deed.*

*The grantor herein agrees to pay the taxes for the year 1926.*
