Smith, his heirs and assigns forever; all that certain tract, parcel or lot of land situated, lying and being in Greenville Township, Greenville County, State of South Carolina, and having the following lines and bounds, to wit: Beginning at an iron pin on the East Washington Road, corner of lot #40 and #41, and running thence S. 15° 30' E. 50 feet to an iron pin, on Royal Spring Road; thence in a north-easterly direction along Royal Spring Avenue 50 feet to corner of lots #40 and #41; thence N. 17° 30' E. 170 feet to an iron pin, on Washington Road; thence in a south-westerly direction along said Washington Road 50 feet to the beginning corner, and being known and designated as lot #40 in Black "D" as shown on plat recorded in Plat Book "A" at page 383.
