Matherman, Jr. dated December 10, 1922, being a part of lot 1 in book 174 subdivision and having a frontage on Park Road of fifty (50) feet and running on park road parallel lines one hundred and thirty three (33) feet more or less. The same parcel of land conveyed to me by Walter H. Goldsmith, by deed not yet recorded. The deed above referred to is recorded in 3106 Greenville County in Plat Book 2, page 101 in volume 10 in which is hereby erased for all purposes the description of said lot. The said Cassie Forest hereby assumes and agrees to pay the said note and mortgage executed by W. M. Matherman and Walter H.
