will be granted two certain lots or parcels of
land, situate, etc., lot No. 4, in Block 1,
South Street, a subdivision of the City of Greenville,
and situated just outside of City of Greenville
and running back from the following lines, metes and
bounds, to wit: Beginning at a stake in
the west side of Avenue B, in corner of
lot No. 1, and running thence along said
said Avenue, one hundred (100) feet to a
marker in the corner of lot No. 4, thence 141 feet
to a tree foot marker, thence along said valley
to a stake in corner of lot No. 1, thence along
the line of lot No. 1, to the beginning
of said tract of land, as shown on a
plat of said addition on file in
the office of the R. M. C. for Greenville County
in Plat Book 22, at page 119, and being a
