All that certain Parcel or lot of land situate, lying and being in the County and State aforesaid, in the City of Greenville, on the west side of Fall Street, and being known and designated as lot no. 4, upon a Plat of the Property of *Jas. M. Richardson and H. B. Bates*, and being described as follows: Beginning at an iron Pin on west side of Fall Street at corner of lot no. 5, and running thence along Fall Street N. 27.30 E. 23 feet 8 inches to iron Pin at corner of lot no. 3; thence along line of lot no. 3, N. 62.30 W. 82 feet 5 inches to an iron Pin at a 15 foot alley and at corner of lot # 3; thence along said alley S. 27.30 W. 23 feet 8 in. to an iron Pin at corner of lot no. 5; thence along line of lot no. 5, S. 62.30 E. 82 feet 5 inches to the beginning corner.
