C. Cleveland Property, made by R. E. Dalton, March 14, 1910, and recorded in the office of the Register of Deeds, Conveyances for Greenville County, South Carolina in Plat Book "B", said lot having a frontage of Seventy feet on Poinsett Avenue, and running back along parallel lines, a depth of one hundred fifty feet, more or less, and a width along the rear line of 75 feet, more or less, and being the same lot conveyed to me by E.
