E. Godfrey Webster and his heirs and assigns,
 and his co-tenant one half interest in and to all those
 two parcels of land in the City of
 Greenville, in the County and State aforesaid
 containing the following described and bounded:
 First, all that lot known as the western portion of
 number seven (7) on plan of the lands of the West End
 Land and Improvement Company, recorded in office
 by P. M. C. for said County in that book, "at page
 153, the portion thereby conveyed running the following width
 and bounds, beginning at the corner of McKay
 street and an un-numbered street and running thence
 along McKay street N. 77° 31' E. Ninety-four (94)
 feet to a stake or post at corner of lot of Joe
 Capadicio, piece along the lot N. 11 W. fifty (50)
 feet to another stake on side of lot
 N. 77° 31' E. 150 feet. From to go stake on side of lot
 N. 77° 31' E. along said lot, E. 79 W. Ninety-four (94)
 feet to a stake on unnumbered street, thence
 along said street, N. 11 E. thirty-four (34) feet to
 the beginning corner.
