assigns.

I, the first piece, parcel or lot of land in Austin
Township, Greenville County, state of South Carolina
and in the town of Mauldin, known and design-
ated as lots No. 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19
No. 25 and a 6 acre tract of property of M. J. T.
Forester made by myself, I, myself, and re-
corded in office of C. H. C. for said County in Plat
Book 1 page 25, reference to said plat being hereby
granted for a more particular description, please,
however, file part first No. 1 heretofore conveyed
by M. J. Forester to D. B. Thompson by deed dated
October 6, 1918 and recorded in Book 58 page 33, and
also the tract or lot No. 1 conveyed to Frank Shaver
by deed dated September 21, 1914, recorded in the
