all that certain lot of land in Greenville Township, Greenville County, State of South Carolina, near the Anderson Road, being Lot no. 10, on a Plat made by Fitz-Patrick Terry Co., Engrs. March, 1920, entitled "Tract No. 7, Judson Mill Property, sub-division near Anderson Road, owned by J. O. Weatherly", said Plat to be recorded in R. M. C. office for Greenville County, and having the following metes and bounds:

Beginning at a Point on the South Side of Weatherly Drive, corner of Lot no. 11, (which is 142.6 feet from Judson Road,) and thence with line of lot no. 11, 185 feet, more or less, to an iron Pin in line of lot no. 13; thence with line of lot no. 13, S. 64-42 E. 46.7 feet to iron Pin corner of lot no. 9; thence with line of lot no. 9, 190 feet, more or less, to iron Pin on Weatherly Drive; and thence with Weatherly Drive N. 69-26 W. 62.6 feet to the beginning corner, being a Partion of the same conveyed to J.
