the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said *C. D. Pace*, all that tract or parcel of land situated, lying and being in the aforesaid State and County, and being a portion of the land deeded to *T. H. Reid, deceased*, by *J. T. Brewster* and which was originally known as the *Broadway Lands*.

Beginning at a stone, a corner of the tract of land this day deeded to *C. D. Pace*, thence N. 26° 58' E. 1760 feet to a stone, the *Bellemeade* lands; thence S. 70° 58' E. 1222 ft. to stone, the Carpenter and Earle lands; thence S. 44° 06' W. 816 ft. to stone, thence S. 27° 20' W. 1160 ft. to stone, corner of *C. D. Pace* land, thence a new line N. 68° 37' W. 946 ft. to the beginning corner, and containe forty acre and 63 per acre, more or less, bounded by lands of *T. H. Reid*, *C. D. Pace* and others.
