Beginning at an iron post in the Eastern line of corner no. 19, point 18, of lot no. 18 and 20, and running thence south 60° 30' west 162 feet to another iron post in line of lot 18, 175 feet to an iron post in line of lot 20, 175 feet to the front corner of lots nos. 19 and 20; thence north 15° 45' west 162 feet to the front corner of lots nos. 19 and 20; thence north 15° 45' west 162 feet to an iron post in the Eastern line of corner no. 19, 175 feet to an iron post in the Eastern line of corner no. 18; thence with said corner post, 60 feet to the point of beginning.

In Part of the consideration for this deed, the grantor promises and agrees to pay the balance of \$3500.00 with interest thereon from September 1st, 1928 on the \$5500.00 mortgage executed by Eddie A. Smith to A. S. L. Barkdale, June 27th, 1928, which mortgage is recorded in the R. S. L. office for Greenville County in real estate mortgages volume 181 Page 101, which is now buried by Clinton F. Morgan and James H. Morgan, Jr. as Executrix.

The grantor also assumes the balance due on Paving of Jones Avenue.

The above described land is the same conveyed to me by W. L. Garrison, T. G. Gowers and C. M. Martin on the 20th day of June, 1928, deed recorded in office of Register of Deeds Conveyances for Greenville County in Book 125, Page 296.
