"All that certain lot of land situate on the West side of South Main Street in the 5th Ward of the City of Greenville, County and State aforesaid, known and designated as Lot 6 as shown on plat recorded in R. M. C. Office for Greenville County Plat Book "C" page 49, and having the following metes and bounds, to wit:

Beginning on the West side of South Main Street at a point opposite center of brick wall all between this lot and lot five and running thence with center of said wall N. 58-05' 33 feet 2 inches; thence N. 35-55' E. approximately twenty one feet to point opposite center of brick wall between this lot and lot seven; thence with center of said last mentioned brick wall S. 58-05' E. 33 feet 5 inches to South Main Street; thence with South Main Street 31-55' W. twenty one feet to the beginning corner, being the same lot conveyed to J. A. McHugh by G. L. Brown, Master.
