demanding relief as to the real estate described in the complaint; and the cause being at issue, came on to be heard on the 16th day of February, 1926 and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Mrs. Virginia M. Price and her heirs and assigns forever,

the following described real estate,

C. lot certain tract of land in Butler Township, County of Greenville, State of South Carolina, and being known and designated as Tract No. 6, as it now is by the partition of the estate of Mrs. Jessie A. Miller, made by Commissioners in Partition June 17, 1924, in accordance with a suit, division, and plat of said property, made by C. M. Fussman, Esq., on Aug. 1919, said plat being of record in the R. M. C. Office for the County of Greenville, forwarded, in "Flat Book E", at page 160, and particularly described as follows:

Beginning at a tree oak near the Greenville-Simpsonville road and in line of Tract No. 5, and running thence S. 64-45-6. 11-42 to west line; whence N. 84-25-6. 16-50 to a stone; thence S. 19-43-6. 60-50 to stone; whence N. 20-15-6. 4-75 to stone; whence S. 87-45-6. 11-74 to stone; whence S. 10-30-6. 0-50 to pipe at corner of Tract No. 4; whence along the line of tract No. 4, S. 3-45-6. 11-42 to pipe at corner of tract No. 5; whence along the line of tract No. 5, S. 3-45-6. 43-32 to the beginning corner, and containing 130.45 acres, more or less, and being the tract of land allotted to Mrs. Virginia M.
