Demanding relief as to the real estate described in the complaint; and the cause being at issue, came on to be heard on the 1st day of November, 1928, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinabove mentioned and described, be conveyed by Clyatt Aiken,

 NOW, Therefore, Know all Men by these Presents, that I, Clyatt Aiken,  
 Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree,  
 HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said

Curtis M. Hamby, Richard Hamby and Mabel Hamby, the following described real estate, to-wit, all that certain piece, parcel or lot of land situated, lying and being in Greenville County, State of South Carolina, on the Laurens Road, about 1 1/2 miles East of the City of Greenville, having the following streets and boundaries, to-wit: Beginning at a stone on the Laurens Road, corner of Gray's corner, and running thence with said road N. 32° W. 105 feet to an iron pin, thence S. 36° 24' W. 11 1/2 chs. more or less, to an iron pin; thence S. 51° 10' W. 105 feet, more or less, to a iron pin and corner of Gray's line, thence with said corner and Gray's line N. 36° 24' W. 105 chs. to the beginning corner.

Also: all that other certain piece, parcel or lot of land situated, lying and being in Greenville County and State aforesaid, next the above described lot, and having the following streets and boundaries, to-wit: Beginning at a iron pin on the Laurens Road at corner of Gray's corner, and running thence with said line S. 30° 10' E. 317 chs. to an iron pin, thence S. 32° 10' E. 317 chs. more or less, to an iron pin; thence N. 36° 24' E. 31.17 chs. more or less, to an iron pin in the Laurens Road, thence with said road N. 32° W. 11 1/2 feet, more or less to the beginning corner.
