demanding relief as to the real estate described in the complaint; and the cause being at issue, came on to be heard on the 3rd day of July, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinabove mentioned and described, be conveyed by

Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree,

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said

J. H. Rush, the following-described real estate:

Tell that certain lot of land situated lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, and on the northeast corner of E. McFee Avenue and Divine Street and being known and designated as lot no. 1, on plat record in the R. M. C. office for Greenville County in Plat Book G page 24, and having the following metes and bounds and curvys and distances, as shown by said plat, to-wit:

Beginning at an iron pin at corner of E. McFee Avenue and Divine Street and running thence along the line of said E. McFee Avenue S. 70° 30' E. 62.75 ft. to an iron pin at the corner of lot no. 2, thence along the line of this lot N. 20.54 E. 177.6 ft. to a point in line of the property of the Wade Estate, thence along the line of the Wade Estate N. 70.27 E. approximately 61.3 ft. to an iron pin in line of Divine Street, thence along the line of said Divine Street S. 21.25 E. 177.4 ft. to the beginning corner. The lot herein conveyed is lot no. 1, as shown in the partition of property of N. N. Watkins, et al. and was assigned by the Commissioners in partition to J. H. Rush. An Alley way 20 ft wide, along the rear of said lot, and extending from Church Street to Divine Street, is reserved for the use and benefit of the five lots for equal partition and has been and the plat hereinabove referred to as recommended by the Commissioners in partition
