(1) The grantee herein binds himself, his heirs and assigns not to publicly advertise for sale any lot or lots in this subdivision at a price less than that which the grantee is lawfully entitled to receive in said Carolands Estate.

(2) No lot in this subdivision shall be sold, leased or otherwise disposed of directly or indirectly, by any title hereon, to any person of which any stockholder shall be of the Caucasian Race.
