KNOW ALL MEN BY THESE PRESENTS, That

Furman University

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Two thousand five hundred (500.00) DOLLARS,

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee..... hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto D. A. Taylor all that certain lot of land situate in said County described as follows:

Beginning at an iron pin on the south east corner of Augusta and Garrison Streets and running thence with Augusta St. S. 11° E. 217.8 ft. to an iron pin; corner of lot # 20 now owned by J. R. Bryson; thence with line of that lot N. 81° E. 172.6 ft. to an iron pin; thence still with line of that lot S. 11° E. 72.6 ft. to an iron pin on the property line; thence with old property line N. 81° E. 507.6 ft. to an iron pin on Nona Street; thence along Nona St. in a northerly direction 27.9 ft. more or less to an iron pin, corner of property formerly owned by W. S. Foster; thence with line of that property S. 06 M. 60 sec. 60 an iron pin; thence still with line of that property N. 23 W. 210 ft. to an iron pin on Garrison St.; thence with Garrison St. in a westerly direction 5.8 ft. more or less to the point of beginning also in that other parcel or lot of land situate lying and lying in Ward 6, in the City of Greenville, County and State aforesaid, and having the following lines, and boundaries according to a plan recorded in Plat Book 5 at page 260.

Beginning at an iron pin on the west side of Nona St. 66 ft. north of the northwest corner of Hayne and Nona Streets and running thence S. 81° W. 193.72 ft. to an iron pin; thence N. 15° 1/2 W. 13.2 ft. to an iron pin on Nona St.; thence with Nona St. S. 15-1/2 E. 13.2 ft. to the point of beginning.

in trust, nevertheless, to collect the rents and profits to manage and control said lands to operate and deliver a mortgage on said lands upon such terms as he may deem advisable, in a sum not in excess of twenty-eight thousand (28,000.00) dollars, and, to, from the proceeds thereof, pay off a note in the sum of twenty seven thousand five hundred (27,500.00) dollars now held by The South Carolina National Bank, of Charleston, which note represents the purchase price of the said lands herein described, and with the further power in said Trustee to sell all or any part of said lands at such time and upon such terms as he may deem advisable, and to, from the proceeds thereof, pay said mortgage, indebtedness and expenses of this trust, paying the balance remaining if any, to Furman University, and to them, if any funds remain, due same to Furman University, free of all trust; or said Trustee may at once convey said land to Furman University subject to said mortgage.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee..... hereinabove named, and..... his successors

heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee..... hereinabove named, and..... his successors heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

on this the nineteenth day of August in the year of our Lord one thousand nine hundred and forty-seven and in the one hundred and fifty-second year of the Sovereignty and Independence of the United States of America.
