to it in hand duly paid at and before the sealing and delivery of these presents by the grantee..... hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto George H. Hissine,

C. M. Blythe, Fred H. Graham, Julius P. Charles, J. F. Robertson, M. L. Marchant and M. D. Carle as Trustees of the School District of the City of Greenville.

A certain lot of land situated in the City of Greenville, in the County and State aforesaid, having the following metes and bounds to-wit:

Beginning at a stake on the Southwest corner of Fair Street and Oakland Ave. and running thence with Oakland Ave. S. 74.50th. 288.2 feet to the corner of Oakland Ave. and Chase Street; thence with Chase Street N. 16.01th. 293.25 feet to a stake; thence S. 22-196.202.45 feet to a stake on Fair Street; thence with Fair Street S. 62-196.34th. 20 feet to the beginning corner, being known and designated as Lots Nos. 44, 45, 46, 47, 48, 49 and 50 of Oaklands Heights and being the same land conveyed to Campdown Mills by J.
