all that piece, parcel or lot of land in Greenville-Township, Ward, City of Greenville-Greenville County, State of South Carolina, located, situated and being on the West side of McDaniel Avenue and being written and designated as lot No. 2, plat of Matthew W. Glaser property made by C. E. Dalton, Engineer, June 1934, and having the following metes and bounds, to-wit:

Beginning at point on street side of McDaniel Avenue just S. of intersection of McDaniel Avenue and Wm. Glaser Avenue, thence along No. 1, Th. 88-38 R. 197.7 ft. to corner of said line & lot 1-0 ft. A. A. Green, then with Green Street, 5 ft. 65 ft. to iron pipe corner No. 2 and 3, thence with No. 3 Th. 88-38 R. 198.8 ft. to iron pipe on McDaniel Avenue, thence with McDaniel Avenue No. 3-48 L. 35 ft. to beginning.
