All that certain piece, parcel or lot of land situate, lying and being on the south side of Croft Street, in the City of Greenville State and County aforesaid, and being known and designated as lot # 3 on the plat of the property of C. C. Stone as per plat of said property by Dalton and Nease, C. E., in 1925, said tract being recorded in the R. M. & Office for Greenville County in Plat Book 8 at page 27. The said lot is more particularly described as follows:

Beginning at an iron pipe on the south side of Croft Street, at the corner of the property of C. C. Stone, and running thence with the line of Stone S 1-05 E 165 feet to an iron pipe at the corner of said lot # 3, thence with line of said lot S 16-06 E 50 feet to an iron pipe at the corner of lot # 3, thence with line of said lot N 16-05 E 165' to an iron pipe on the south side of Croft Street, thence with said Croft Street N 86-06 E 50 feet to the beginning corners.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee..... hereinabove named, and his heirs and assigns, against itself and its successors, and against every person whosoever lawfully claiming or to claim the same or any part thereof.
