to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

Waddy R. Thomson

that certain piece parcel or lot of land with the buildings and improvements thereon situate in the City of Greenville, County of Greenville, State of South Carolina and being more particularly described as follows:-

Beginning at an iron pin on the north-east side of Hannibal Street and running thence S. 36-4 E. 100 feet to an iron pin on said street, thence N. 38-55 E. 191.6 feet to an iron pin on an unnamed street, thence with unnamed street N. 30-30 W. 103.4 feet to an iron pin, thence S. 38-55 W. 204.3 feet to the beginning corner.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinafter named, and his heirs and assigns, against itself and its successors, and against every person who may lawfully claim or to claim the same or any part thereof.
