All that certain piece, parcel or lot of land situate and being in the County and State aforesaid, on the south side of Wooddale Avenue, and having the following metes and bounds, to wit:
Beginning at a stake at corner of lot #236 and running thence with Wooddale Avenue N. 66-37 E. 70' to a stake, thence S. 25-23 E. 225' to a stake, thence S. 62-30 W. 70' to a stake, thence with line of lot #236 N. 25-23 W. 225' to the point of beginning, and being lot #237 of Trolley Park

Subject however, to the following restrictions:

1. No part of said lot shall be used for any purpose other than a single or multiple residence and outbuildings properly appurtenant thereto.
2. No part of said lot shall be occupied by any person of the negroed race except in the capacity of a servant.
3. Out buildings properly appurtenant to a residence shall be confined to the rear half of the lot upon which they are built unless they shall be integral to the residence to which they appertain.
4. No part of any residence may be built or extend nearer to the front property line of said lot than 3.5 feet.
5. No residence may be built upon any lot fronting upon Ayd Boulevard or Park Drive which shall have when completed, a reasonable value of less than \$4,000.00 and no residence may be built upon any lot fronting upon Rock Creek Drive,

Woodvale Ave., or Mountain Ave. which shall when complete have a reasonable value of less than \$3,500.00.
6. No spirituous or malt liquor shall ever be manufactured or sold upon said lot.

7. These restrictions are imposed for the benefit of the grantor and may be modified by it when strict modification is desired by him to the best interest of all concerned.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee..... hereinabove named, and..... her
heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee..... hereinabove named, and..... her
heirs and assigns, against itself and its successors, and against every person whatsoever lawfully claiming or to claim the same or any part thereof.
