all that piece, parcel or lot of land in Freeville Township, Greenville County, State of South Carolina.

between Managhan and Woodside Cotton Mills known as lot No. 14 on plat of sub-division known as Morgan Hill, recorded in Plat Book B, page 70, and having the following dimensions and encumbrances according to said plat: Beginning at a stake on Brandon Road, east corner of Woodside Avenue, and measuring thence which Brandon Road N. 13 1/2 E. 61.872 feet to iron pin; thence N. 85 1/2 E. 16 1/2 feet to iron pin; thence S. 7 1/2 E. 65 feet to iron pin; thence S. 85 1/2 E. 18 1/2 feet to iron pin. This conveyance is made subject to a mortgage for \$1000 recorded in Plat Book B, page 38. Upon the following trust, however: (1) To receive the rents, income and profits therefrom, and to pay the taxes, insurance and repairs, and to sell and convey the same and apply the proceeds of sale as follows: (a) To pay the necessary expenses incurred in carrying out the provisions of the trust herein indicated. (b) To pay the note of Jno. A. Russell to Ed. Law in the sum of \$300.00. (c) To pay to Ed. Law the sum of three thousand dollars on a note dated January 24, 1925 and to pay to Ed. Law the sum of thirty-two hundred twenty dollars on a note dated December 29, 1924, due January 31, 1926, the two notes last mentioned to show liability in the proceeds of sale. (d) To pay over the balance, if any, to Jno. A. Russell. This undertaking and agreed that John H. Lipscomb assumes no personal liability for the mortgage indebtedness now existing on the above described lot.

The above described land is the same conveyed to me by Annandal Austin recorded in office of Mesne Conveyance for Greenville County, in Book 67 Page 212 1926 deed.
