All that certain lot or parcel of land  
situate, lying and being on the North side of  
Ridgeland Avenue, in the City of Greenville, South  
Carolina, and being known and designated as  
lot No. 19 of Cleveland Terrace, as shown on a  
plat made by Dalton & Morris, Engineers, and  
Surveying, according to said plat, the following  
miles and bounds, to wit:-

Beginning at an iron pin in the Northern  
line of Ridgeland Avenue, joint corner of Lots  
Nos. 18 and 19, and running thence with the  
joint line of said lots N. 89. 31 E. 157 feet to an  
iron pin in line of a 15 foot alley, thence  
west said alley N. 69. 18 E. 70 feet to an iron  
pin, corner of Lot No. 20; thence with the line  
of said lot, N. 4. 31 W. 178 feet to an iron pin in  
the Northern line of Ridgeland Avenue, thence  
with said Avenue, S. 86. 19 E. 70 feet to the point  
of beginning.

shall be used in connection with a dwelling.  
(2) No building shall be erected nearer the dwelling sidewalk than  
Sixty feet.  
(3) The property hereby conveyed shall never be sold, rented or otherwise  
disposed of to any person or persons having any percentage of Negro blood.  
(4) The property hereby conveyed shall be used only for residential purposes.
