All that certain piece, parcel or tract of land situate, lying and being in the County and State aforesaid, on the Greenville and Laurens Road, about five miles from the City of Greenville, in Aulden Township, having the following lines and bounds, to wit: Beginning at an iron pin on the north side of the Greenville and Laurens Road, and running thence with said road S. 67° 00' E. 403 feet to an iron pin; thence N. 11° 25' 24. 1265 feet to an iron pin; thence N. 35° 10' 24. 1265 feet to an iron pin; thence N. 35° 30' 24. 420 feet to an iron pin; thence S. 24° 10' 24. 1097 feet to a rock; thence S. 10° 00' E. 545 feet to the beginning, containing 18.45 acres, being designated as tract number One on a plat made by Dalton and Neves, Engineers Feb 1929, of the H. C. Grace Property.
