E. J. Bayne and Leila May Bayne
all that certain piece, parcel, or tract of
land in Saluda Township, Greenville County
S.C. containing ninety-four (94) acres, more
or less, and having the following metes and
bounds, to wit:

Beginning at a red oak 3131 and running
S. 71° 31' E. 23 to a Spanish oak 3131; thence S. 43° 2'
E. 9.21 to a Post Oak 3131; thence S. 66° 9.00 to a
stone 31 in the Meeting House Road; thence along
said road 16.98 to a stone; thence N. 112° 12.50
to a stone 31 on the bank of Musk Creek;
thence N. 41° 23.100 to a stone 31; thence N. 10° 1/2 E.
2.35 to a stone; thence N. 37° 1/2 E. 1.82 to a stake
in branch, thence down said branch 3.50 to a
pile of rocks; thence N. 12° E. 7.12 to a forked
pine (down) 3131; thence N. 15° 24. 7.70 to a stake
in small branch; thence up said branch to
the head, and up a hollow and extending
beyond the head of the hollow to a Sourwood
3131 on the bank line; thence with said line
S. 54° E. 15.90 to a Red Oak dead, and down, James
persons and Crucilla Co's corner; thence S.
