I now all now by these presents
that I, M. C. Cepes, of said County and State for
certain consideration of the sum of One thousand
Dollars to me in hand paid by H. N. Slater,
the receipt whereof is hereby acknowledged,
do hereby grant unto the said H. N. Slater, his
successors, heirs and assigns for a period
of thirty days from this date, the option to
purchase for the sum of Two thousand Dollars
the right, privilege and easement to go in
and upon that tract of land, situated in
Butler Townships, in said County and State,
bounded by lands of H. J. Guest, H. P. Basson,
and North Saluda River. This right of way
is intended to permit H. N. Slater to tap
the Carib Water line at any point within
300 feet west of the Packens road and to
cross my lands in a northerly direction
to lands of H. J. Guest and to construct
a and maintain, upon and through said
premises, a pipe line in manner, with necessary
apparatus and appliances such as machinery,
air vents, catch manholes, and blow off con-
nections, a pipeline for the purpose of
conveying water through premises above
described, together with the right at all
times to enter upon said premises for
the purpose of inspecting said line and
making necessary repairs and alterations
thereon, together with the right to cut
away and keep clear of said pipe line,
all trees, and other obstructions that
may in any way endanger the proper
operation of same.

This is understood and agreed that
the right of way to be used under this
contract is to be fifty feet in width
throughout the entire length which is
about 200 feet, more or less.

This further understood that
this easement is fifty feet in width to
be used only during the construction
of said pipe line and with the excep-
tion of the right of H. N. Slater, his successor,
heirs and assigns, to inspect pipe line
and to make repairs, the owner has

privileges and rights to cultivate and use
the land as he had prior to the agreement.
He further agreed that in case
of future damages to land or crop due
from an accident on pipe line, that
H. N. Slater, his successors, heirs and assigns,
shall pay all damages.

The payment above specified is
accepted in full settlement of all claims
and damages for said easement for
said pipe line laid.
