All that certain piece, parcel or lot of land in the City of Greenville and the North side of Cow Street known and designated as Lot No. 2 and part of property of *A. C. Stalley and A. M. Howard* as heretofore in Plat Book 49, page 162, and showing the following metes and bounds, to wit:
Beginning at a point on the North side of Cow Street 66 feet from the northeast corner of *Clay and Olive* Street and running thence parallel with *Clay Street* N. 73.6. 117 feet; thence N. 18.7. 60 feet; thence S. 72.4. 117 feet to a W. pin on *Clay Street*; thence with *Clay Street* S. 18.6. 60 feet to the beginning corner.
This being same lot as designated on above plat except that three (3) feet has been cut off the rear of same, leaving a depth of 117 feet instead of 120 feet as shown on said plat.
