(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

*J. B. Wood, Julia L. Wood and Elizabeth Wood* all that certain piece, parcel or tract of land situated in the County and State aforesaid, about one mile North of Simpsonville on the Greenville and Lawrence roads, adjoining lands of *J. B. Hunter, J. A. Martin and others*, and being part of the Amanda A. Stokes land with the exception of such together as an acre bought from Mrs. B. Hunter, and having the following section and bounds, to wit: Beginning at the center section of the Greenville and Lawrence Road, and running thence S. 42 1/2° E. 17.05 to a stone, thence N. 29 1/2° E. 15.16 to center of road, thence with said road N. 42 1/2° E. 2.56 to bend, thence N. 50 1/2° E. 3.30 to bend, thence N. 46 1/2° E. 7.17 to center of Felham Road, thence S. 49 1/2° E. 3.80 to bend, thence S. 61 1/2° E. 3.30 to the beginning and containing 1.9 acres, more or less.

Also, all that other certain piece, parcel or tract of land situated in Auctis township, said County and State adjoining lands of *J. L. Smith, J. A.
