Smith, Agent, the receipt whereof is hereby acknowledged do hereby grant unto the said Aug. H. Smith, agent, his successors, heirs and assigns for a period of 16 days from this date, the option to purchase for the sum of Eleven hundred \$1100.00 Dollars the right, privilege and easement to go in and upon that tract of land situated in Gates Township, in said County and State, bounded by lands of F. H. Eubanks, Dr. B. F. Goodlett, J. L. Shattox and the Reel Creek Mills, being Tracts Nos 2 and 3 of the T.M. Edwards land on the McElhaney Road and to construct and maintain in, upon and through said premises, in a proper manner, with necessary apparatus and appliances such as machinery, air vents with manholes, a Pipe Line for the purpose of conveying waste through premises above described, together with the right at all times to enter upon said premises for the purpose of conveying waste through premises above described, together with the right at all times to enter upon said premises for the purpose of inspecting said line and making necessary repairs and alterations thereon, together with the right to cut away and keep clear of said Pipe Line all trees and other obstructions that may in any way endanger the proper operation of same.

It is understood and agreed that the right of way to be used under this contract is to be 75 feet in width throughout the entire length which is the full length of my property.

It is further understood that this easement of 75 feet in width is to be used only during the construction of said Pipe line, and with the exception of the right of Aug. H. Smith, Agent, his successors, heirs and assigns, to inspect Pipe line and to make repairs, the owner has the same privilege and rights to cultivate and use the land as he had prior to this agreement.

It is further understood, that in case of future damages to land or crop due from the accident on Pipe Line, that Aug. H. Smith, Agent, his successors, heirs and assigns shall pay all damages.

The payment above specified is accepted in full settlement of all claims and damages for said damage for said Pipe line laid. The above easement is next page.
