in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said *J. W. Shackley*

all that piece, parcel or lot of land in *Black Rock Springs*, Township, Greenville County, State of South Carolina.

in town of Taylors, Black Rock Springs Township, and another East side of the Matthews Highway, being a part of the J.W. Shackley home place, bounded by boundaries of J.W. Vaughan & D. Taylor and other lands of J.W. Shackley, Matthews Highway and the Piedmont & Northern right of way being more fully described by the following metes and bounds, to-wit:-

Beginning a stake and corner of lot No. 25, d. 110. Vaughan's corner and running thence with d. 110. Vaughan's line S. 11.30 E. 150 feet to J.W. Vaughan's corner, so to lot, ally, thence d. 20.81 N. with said ally, so far to stake and J. Shackley Ave., thence W. 1.20 N. with said Avenue 100 feet to stake and Matthews Highway, thence W. 28 E. with highway 100 feet to beginning corner. This tract is described above now (9-10-11-12) according to plat and survey made of J.W. Shackley property for 1913 by J.W. Alexander, Landscap.

Also all that part of land lying back of a house described, lot and extending to the Piedmont & Northern right of way and being lots Nos. 22, 23, 24, 25, 26, 27, 28, 29, 30, and 31 (a triangle) of land on Piedmont & Northern right of way, according to above mentioned plat of J.W. Shackley property having the following points and boundaries, to-wit: Beginning at a stake at intersection of J. Shackley Ave. and ally running back of a house, described, lot and extending to the back of a house, said ally 321 feet to stake and Alexander line, thence S. 11.45 E. with Alexander line about 120 feet to stake near spring and on Piedmont & Northern Right of Way, thence with Right of Way S. 73 N. 320 feet to stake and J. Shackley Ave., thence with Alexander line 11.30 N. 261 feet to beginning corner.

heirs and assigns, against *me* and *my* heirs, and every other person whomsoever lawfully claiming, or to claim the same, or any part thereof.
