in consideration of the sum of Five hundred (\$500.00)

and the assumption of the amount owing on the mortgage herein after mentioned
to me paid by Francesca Fagis and Cannilla Fagis

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Francesca Fagis and Cannilla Fagis, their heirs and assigns,

all that piece, parcel or lot of land in Greenville

Township, Greenville County, State of South Carolina.

About four and one-half (4-1/2) miles from Greenville Court House, South Carolina, containing fourteen and 9/10 (14.9) acres, more or less, and having the following metes and bounds, to wit:

Beginning at a point on Old Anderson Road, and running thence with Tompkins line S. 31° 25' 6.1236.6 feet to Tompkins and Chandler's corner; thence with the Chandler's line N. 37° 14' 4.652 feet to corner of Crocker and Cawthon's land; thence with Cawthon line N. 37° 31' W. 1483.5 feet to Old Anderson Road; thence with Old Anderson Road S. 73° 28' W. 9.9.3 feet; thence continuing with said Anderson Road S. 67° 35' W. 320.2 feet to the beginning corner being the same land which was conveyed to me, the said Thomas Hamilton, by E.
