All that certain piece, Parcel and lot of land situate, lying and being in State and County aforesaid:

Beginning at an iron pin in the Pitham Road and running thence S. 81 $\frac{1}{4}$ E. 7.44 chs. to a stone North of road a.m.; thence S. 27 E. 6.64 links to an iron pin in the Pitham Road; thence S. 65 $\frac{1}{2}$ E. 1.50 chs. to a point in road; thence S. 46 $\frac{1}{2}$ E. 2.50 chs. to a point in road; thence S. 65 $\frac{1}{2}$ E. 1.50 chs. to a point in road; thence S. 79 $\frac{3}{4}$ E. 1.50 chs. to a point in road; thence N. 62 $\frac{1}{2}$ E. 1.00 chs. to a point in road; thence N. 54 $\frac{3}{4}$ E. 2.00 chs. to a point in road; thence N. 69 $\frac{1}{4}$ E. 2.00 chs. to a point in road; thence N. 82 $\frac{1}{2}$ E. 1.00 chs. to a point in road; thence S. 71 $\frac{1}{2}$ E. 1.88 chs. to a point in same road; thence N. 47 E. 1.68 chs. to a stone; thence N. 18 $\frac{1}{2}$ E. 3.28 chs. to a stake; thence S. 75 E. 8.08 chs. to a stone; thence N. 13 E. 3.61 chs. to a stone and iron pin; thence N. 37 $\frac{1}{2}$ E. 7.06 chs. to a stone and iron pin; thence N. 75 W. 14.80 chs. to an iron pin; thence N. 4 $\frac{1}{2}$ W. 24.26 chs. to an iron pin in North edge of the New Greenville & Spur topsoil road (Alridge's corner); thence S. 84 W. 6.36 chs. to an iron pin in North edge of same road; thence S. 20 W. 20.55 chs. to a stone and iron pin in field, O.M. S. 20 W. 6.32 chs. to P.O. 34 corn; thence leaving old line and following a new line run by Mr. A. Adams in 1919 S. 25 W. 11.63 to beginning containing 69 $\frac{5}{8}$ acres, more or less, being lots no. 13 plus 55/100 of lot no. 12 and all of lot no. 14 except a fraction of an acre lying North of the Greenville & Spur topsoil road which was sold off and is more fully described on a plat made by Mr. A. Hudson March 3rd 1909, and also by a plat for 7 1/8 acres made by W. A. Adams. This tract is a part of the land conveyed to E. P. Anderson by Martha A. McCarter and others, on November 26, 1902 and a tract conveyed to E. P. Anderson by J. Lee Greene on Sept. 17th 1900 bounded by lands of E. P. Anderson, J. Lee Greene, McCarter and others.
