That certain lot of land situate on the West side of Anderson Street in the City of Greenville, County of Greenville, State of South Carolina and having, according to a plat thereof prepared by Dalton & Nevels, Engineers, March 19 28 the following metes and bounds, course and distance to-wit:

Beginning at an iron pin on the West side of Anderson Street, which iron pin is 50 feet in a North westerly direction from the intersection of Anderson Street and Henderson Street and running thence along the West side of Anderson Street 29 30-50 8. 72.1 feet to an iron pin; thence N. 73-30 21 315 feet to an iron pin; thence S 16-19 24 70 feet to an iron pin; thence S 73-33 6 176.5 feet to the point of beginning.
